2010 NON_PROFIT Vendor License Agreement Continued Pearl River Day

Vendor will provide all tables, chairs, tablecloths, equipment and labor needed for their respective booth area. No electricity will be provided. Food vendors are responsible for their own permits.

Fees: Non-Profits and Community Groups will not be refunded this year. The Chamber of Commerce spends an enormous amount of their funds on advertising and promoting this event. The event draws thousands of people and is great exposure for anyone who participates. In order to off-set some of our costs we will not be refunding non-profit this year.

Raffles: Free Raffles will be permitted (example: no charge for a free chance to win a prize). No other raffles will be permitted by any group. The Pearl River Chamber of Commerce runs a 50/50 raffle that day that is a main source of fund-raising for this event. Any violation will result in the group being asked to dismantle their display and leave the event.

Set-up time: Vendor can begin set-up between the hours of 7:00am – 9:00am. Vehicles will not be allowed in the event area on Central Avenue after 9:00am. Vehicles in event area after 9:00am will be ticketed and towed away.

Breakdown time: Event ends at 5:00pm. Vendor will begin dismantling their booth at the end of the Event. Vendor vehicles will be allowed in the event area on Central Avenue after 5:15pm. Vendors must be dismantled by 6:15pm. After 6:15pm vehicles and property will be subject to being ticketed and towed from the event area at vendor's expense. Vendor is responsible to leave their respective booth in a broom-cleaned condition.

Parking: Vendor vehicle parking will be at the Franklin Avenue Municipal Lot

Rules & Disclaimers:

Vendors will not deface any private or public property on Central Avenue.

The Pearl River Chamber of Commerce has sole discretion on assignment of booth space.

Vendor will abide by all Federal, State and local municipality laws and regulations. Any violation of the aforementioned will result in the vendor's removal from event area.

Any vendor selling counterfeit merchandise will be removed from event area.

Any and all equipment and property shall be the responsibility of vendor. The Pearl River Chamber of Commerce and its volunteers shall not be responsible for the loss or damage to vendor equipment and property for any cause whatsoever. It is expressly understood that vendor assumes all risk of loss and damage to their equipment and property and that the Pearl River Chamber of Commerce and its volunteers are under no duty to guard such property at any time.

The vendor shall indemnify, save and hold harmless the Pearl River Chamber of Commerce and its volunteers from and against all losses, claims, demands, damages, payments, suits, actions, costs & expenses including but not limited to court costs and reasonable attorney fees, recoveries and judgments of very nature and description incurred by or brought or recoverable against the Pearl River Chamber of Commerce and its volunteers while exhibiting or attending the event or in any consequence of any negligence or carelessness in regarding the same
